The Department of Metropolitan Development would once again like to take this opportunity to invite you to register your neighborhood association with the City of Evansville for 2010. As a neighborhood registered under the Neighborhood Bill of Rights Ordinance G-98-14, you would receive advanced notice of all variance, vacation and zoning changes within your boundaries.

YOUR NEIGHBORHOOD MUST:

1. have a unique name,
2. have specific boundaries, (provide a map)
3. be open for membership to all residents within the neighborhood boundaries,
4. have an open election of officers with specific terms, and
5. have and be following written by-laws.

In order to become a registered neighborhood, you must fill out the enclosed form and return it along with the required documentation.

You must register every year so you can continue to receive mailings from the City. Once you have registered with the City, registration forms will be sent at the beginning of each year thereafter. Should you have any changes between the yearly registration mailings, give me a call and I will send you a new updated form to fill out. Please fill out the enclosed form and return it to U.N.O.E. or the Department of Metropolitan Development by March 1st, 2010.

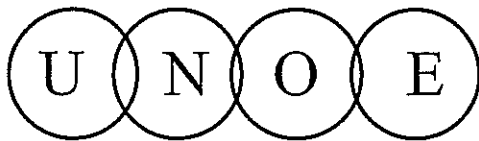

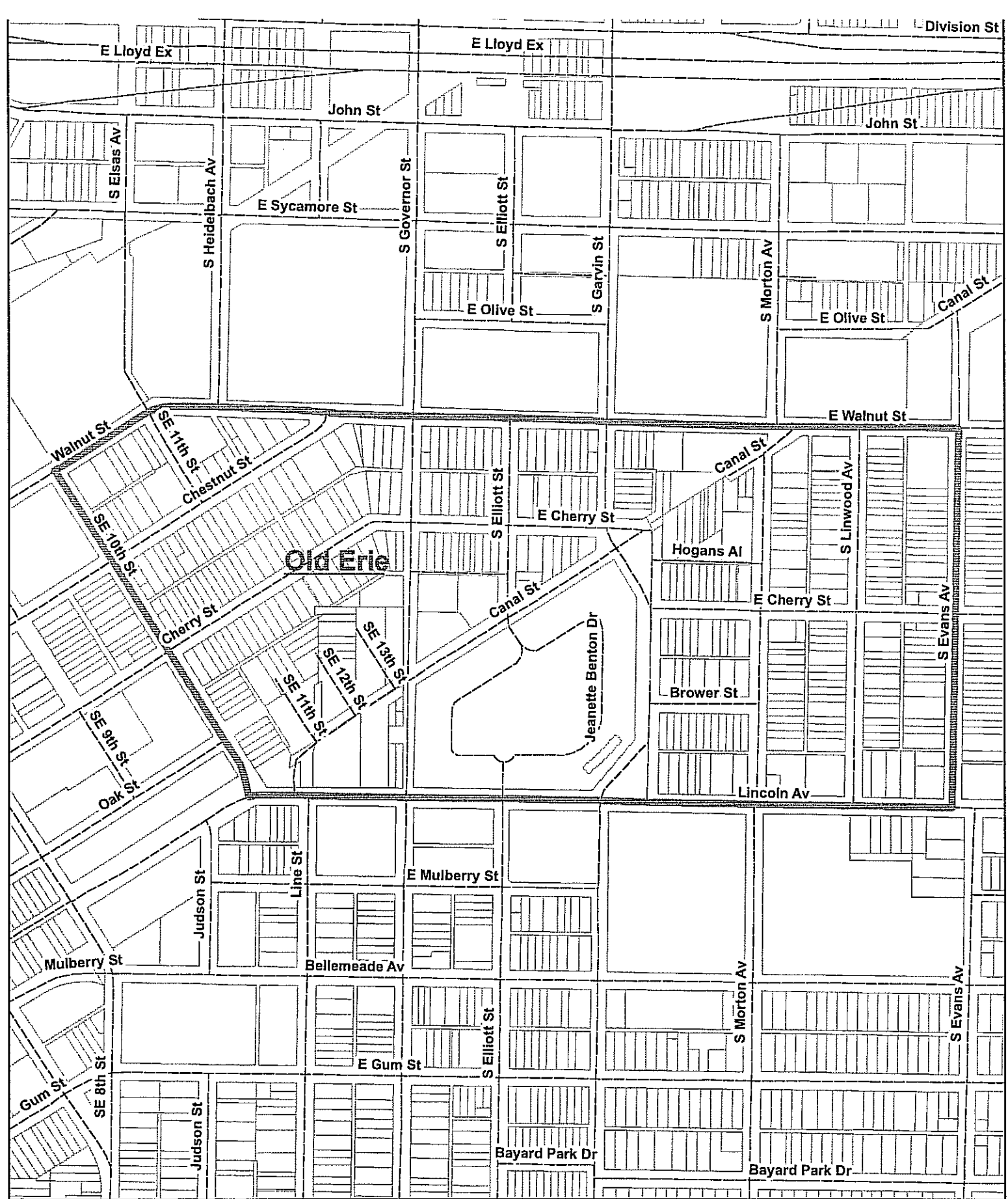
